### GENERAL INFORMATION

1. The festival will be held July 10-11, 2026 with the main festival events occurring on Saturday July 11.
2. You will again be located at the Wash Fin employee parking located at the intersection of Main and Wheeling.
3. Setup can begin at 8:00am on Saturday, July 11th and should be completed by 11:00 am.
4. You will be provided with a 10'x10' area, one 8' table, and two chairs. Fill up the 10' x 10' area as you wish.
5. The location of your space will again be pre-assigned.
6. Tents will not be provided (you can bring your own) and there is no power/electricity.
7. You are welcome to sell items at your table, but no food or beverages.
8. Range Resources will again be sponsoring the History and Heritage Area. **Your group will receive a donation for participating in the festival if you remain setup until 6:00.** Checks will be mailed after the event.
9. Applications must be received by June 1, 2026 and may be submitted by mail or e-mail to the Bradford House Historical Association, P.O. Box 537, Washington, Pa 15301 or info@bradfordhouse.org.
10. We are again inviting our historical groups to participate in a short history parade at the start of the festival. You will walk up Main Street to your table display. **Do you wish to participate in this march: YES or NO**

8. The group is responsible for all supplies needed.
9. No cooking is allowed except those approved by the festival committee.
10. This is a "rain or shine" open air event.
