A MESSAGE FROM THE CHAIRMAN

As I reflect on 2024, I feel immense pride in the transformative strides our Foundation has made in Washington County. Over the past year, we have continued to build on the momentum, sustaining meaningful growth in assets, expanding our programs, and deepening our impact across the region.

This year marked a turning point in the history of the Washington County Community Foundation with the retirement of our long-serving President & CEO, Betsie Trew. For more than two decades, Betsie led the Foundation with vision, integrity, and an unwavering commitment to strengthening our community. Under her leadership, the WCCF grew from modest beginnings to more than \$59 million in assets, established a reputation for excellence in community philanthropy, and launched initiatives that will benefit Washington County for generations to come. Even as we honor the past, we continue to look ahead with optimism and drive, supported by our dedicated team, board, and new President & CEO, Aliesha Walz.

In 2024, we awarded \$3.6 million in grants, including funding for capacity-building and lifelong learning. The Community PILLARS program welcomed its second class, equipping nonprofit leaders with essential knowledge in governance, finance, fundraising, and more.

We are also proud to share that we surpassed our goals for Community Snapshot, our online needs assessment platform featuring more than 100 local nonprofits. Engagement grew significantly in 2024, with nearly 3,000 unique visitors exploring the site. Most importantly, donors directed over \$100,000 from donor-advised funds to address urgent community needs identified through the platform.

Our flagship giving initiative, WCCF Gives, once again united thousands of donors in support of more than 100 local charities, resulting in over \$1.8 million in grants. We are excited to introduce a new giving platform in 2025 that will offer enhanced features and create even more opportunities for nonprofits of all sizes to benefit from this impactful event.

Each grant, whether large or small, strengthens the fabric of a more resilient Washington County.

Today, we stand on a foundation stronger than ever, financially resilient, programmatically robust, and deeply connected to our community. With the continued generosity of donors, support from our new CEO, guidance from our Board, and the dedicated team who make this work possible, we are well-positioned to carry the mission forward.

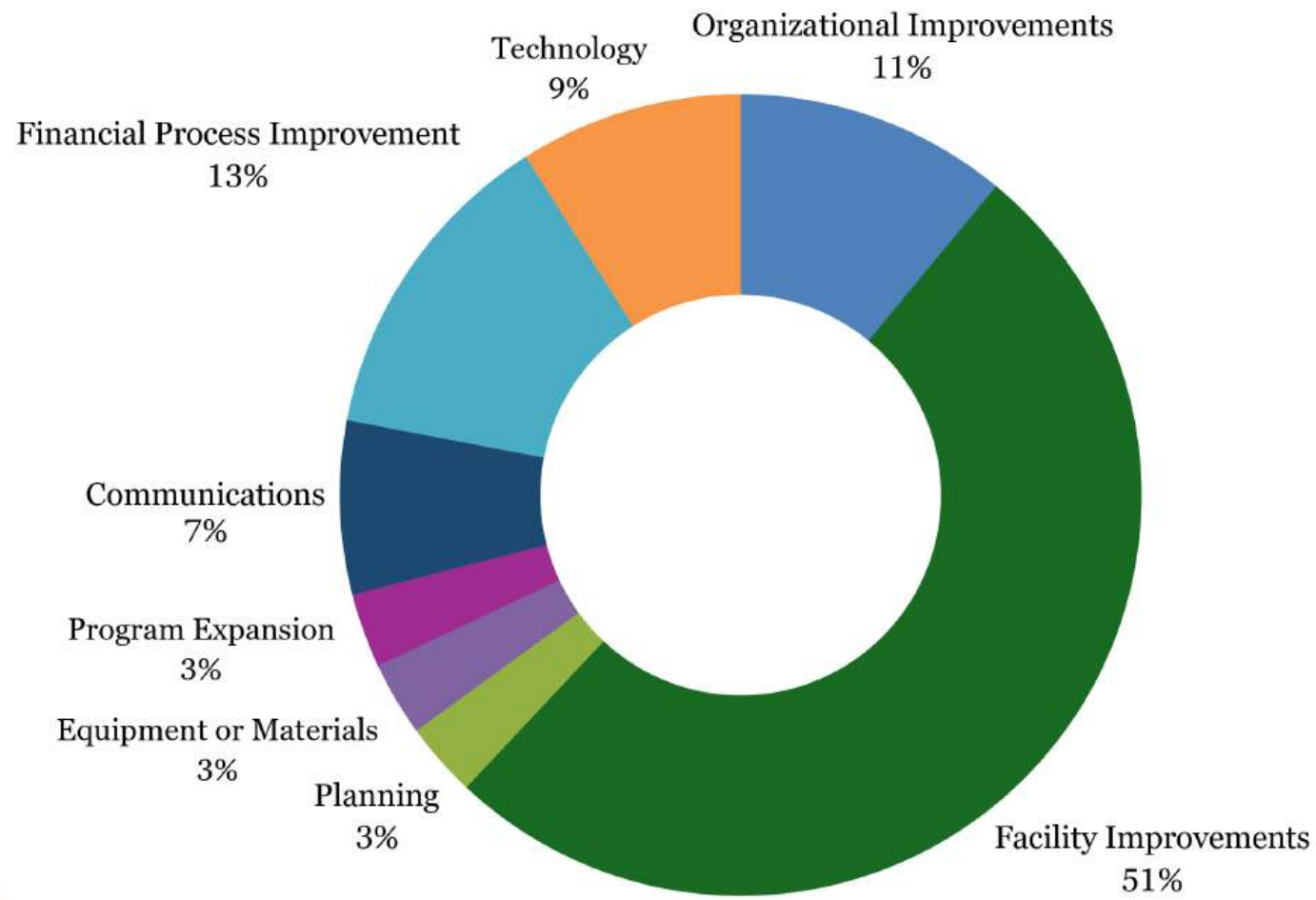

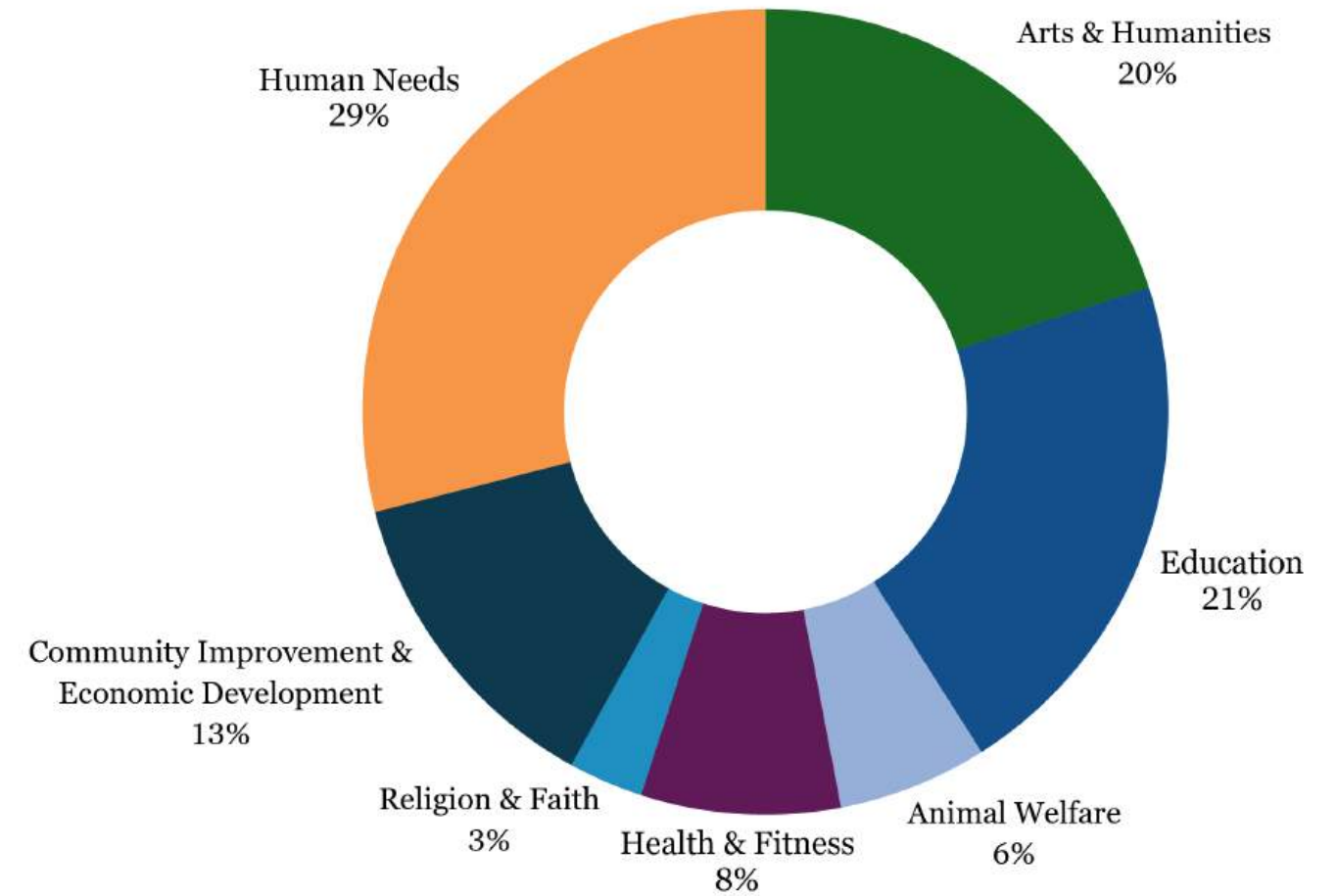

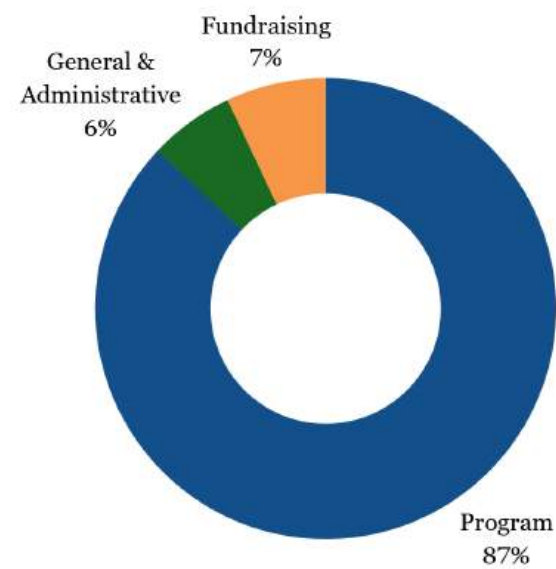
2024 GRANTMAKING BY INTEREST AREA



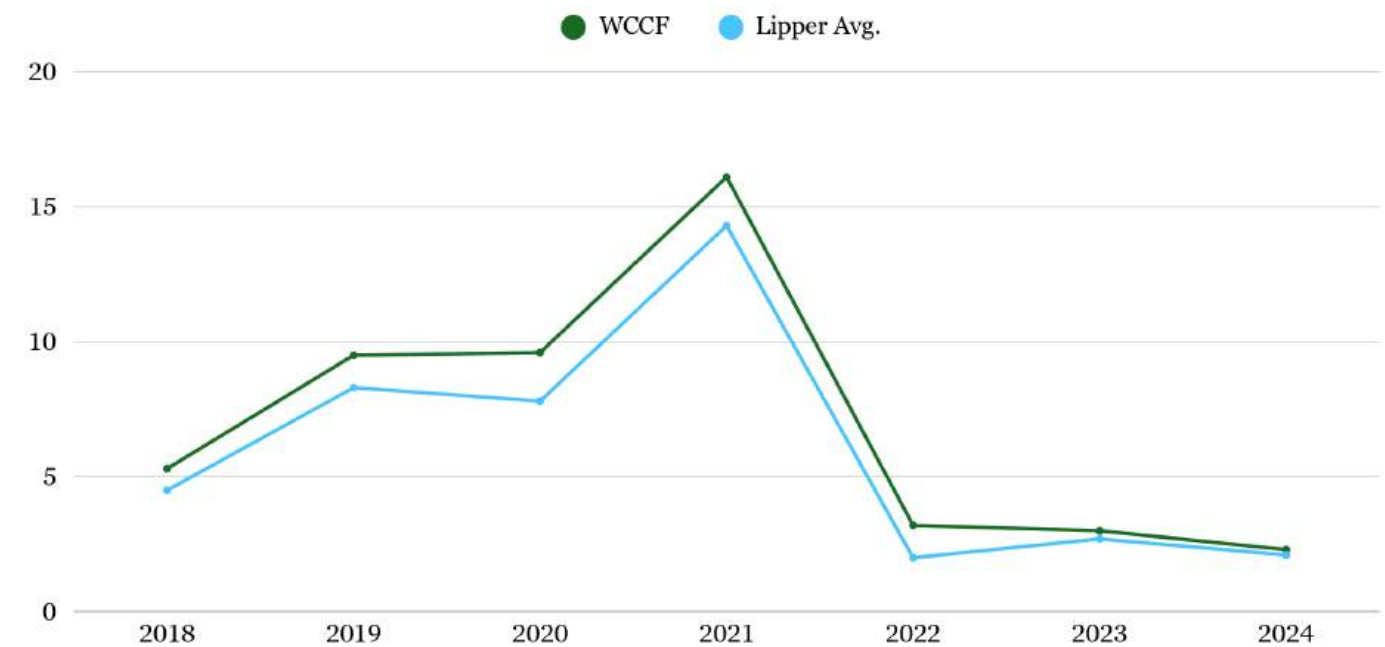
INVESTMENT PORTFOLIO COMPARISON

Grantmaking Impact

At the heart of our mission is a deep commitment to improving the quality of life in Washington County. Thanks to the generosity of our donors and the guidance of our Board, we've awarded grants that address both urgent needs and long-term priorities.

The featured highlights include grants whose impact emerged in 2024, or in some cases, continue to benefit the community years later. These outcomes show how sustained investment leads to lasting change: from programs that uplift local youth, to expanded support for families in crisis, to equipment upgrades that enhance workforce opportunities.

We're proud to see the ripple effects of these grants throughout the county. Looking ahead, we remain committed to data-driven philanthropy, guided in part by tools like CommunitySnapshot.org, to ensure our resources reach where they're needed most.



Improved Access, Increased Impact: Mon Valley Youth's Website Transformation

The Mon Valley Youth & Teen Association in Donora upgraded its website with a \$10,000 grant, improving registration for Camp Watakamini and boosting donations. The new site helps efficiently share information, update families on events, and provide resources to those in need.

With a \$5,000 grant, Blueprints' Little Lift Program supported 28 individuals and families in need. The grants funded essential needs like car repairs for parents, a new bed for a grandmother, and utility payments for a single mother. For these families, the Little Lift Program was more than financial aid—it was a lifeline, ensuring stable homes and helping caregivers thrive.

Youth for Christ: Ensuring Every Student Has a Ride to Success

A \$10,000 grant enabled Youth for Christ Metro Pittsburgh to purchase a 12-passenger van, transporting 30 local students weekly to the Armory Youth Center. The van ensures they can attend after-school programs, sports, and summer camps, offering mentorship and a safe space for growth. Without it, many students, would not have access to these opportunities.

From Outdated to Upgraded: Southwest Training's Technology Transformation

A \$10,000 grant enabled Southwest Training to upgrade to Dell All-in-One computers, providing participants with the tools to access virtual workshops, complete assessments, and attend interviews. This upgrade helps individuals gain the skills and certifications needed for better job opportunities, supporting Southwest Training's mission to prepare them for success in the workforce.



A \$5,000 grant allowed Payne Chapel AME Church Cemetery to add new signage and brochures, creating a space for self-guided tours. This upgrade helps visitors connect with the cemetery's rich history, honoring over 800 individuals, including veterans from multiple wars. The new signage was unveiled during the church's 200th anniversary celebration, ensuring the cemetery's legacy continues to educate and inspire future generations.

Fund Highlight: *Three Oaks Internship Fund*

In June 2024, the Three Oaks Internship Fund awarded a \$1,000 grant to Dress for Success Pittsburgh. The grant provided a stipend for student intern Anahy Corujo, a senior graphic design major at PennWest University. She brings a deep passion for art, design, and community service to her work. Through her internship, Anahy supported the organization's mission by delivering direct services to women in need of clothing and employment readiness support, such as helping clients prepare for interviews, access professional attire, and gain confidence during a pivotal time in their lives.



"I originally moved from Puerto Rico at the age of 19. I am very passionate about art and design," Anahy shared. "I became interested in nonprofits because I believe that a healthy society is one where we help and uplift each other. People who care enough will create change and make the world a better place. I think that, especially in your 20s, there is a moment when you start thinking beyond yourself and wishing certain things were different—or feeling the desire to make a change. I believe that change begins in your community."

Anahy's internship is one example of how the Three Oaks Internship Fund is investing in both the next generation of professionals and the missions of local nonprofits. Created to support charitable organizations by providing stipends to student interns who are actively enrolled in post-secondary education, the fund ensures that interns can be compensated for meaningful work that benefits both their career development and the broader community.

WCCF Gives started as one day of giving but has evolved over time into a giving event conducted over several months. The community giving begins in early summer with check contributions and concludes on a designated day each September when credit card contributions are also accepted through the website. The final day of the giving event is an exciting one, as contribution totals for all charities are displayed in real time on the website leaderboard. The event grows each year and has become a primary fundraising activity for many of the participating charities. Others have shared that participation has helped them attract new donors who first learned about their services through the WCCF Gives website.

In 2024, more than 2,500 generous donors raised \$1.8 million during WCCF Gives, helping 134 local charities secure unrestricted financial support for their missions.

A. Charles C. Keller Excellence Award for Corporate Philanthropy

B. Louis E. Waller Humanitarian Award

Bracken Burns is Washington County’s go-to fixer, always ready to help with community service, whether raising funds for Alzheimer’s patients or advocating for people with disabilities. With a strong work ethic and a passion for service, he’s spent his life tackling social causes, human rights issues, and civic challenges. C. Northrop Family Excellence Award for Community Philanthropy

D. President’s Crystal Award

The **Mon Valley Academy of the Arts (MVAA)**, with locations in Charleroi and Brownsville, makes music education accessible to all. Founded in 2015, it offers free summer concerts, stage experience for young musicians, and lessons in technique, theory, and performance for all ages. The \$10,000 grant will help launch the Empower A Rising Star (EARS) program, providing need-based scholarships for youth music lessons, with plans for future expansion.

E. President’s Silver Award

The **Pennsylvania Trolley Museum (PTM)** preserves the legacy of early 20th-century trolleys that connected communities. Since 1954, the museum has blended history with STEAM education and offers hands-on experiences. Its new Welcome & Education Center explores trolleys’ impact on urban development, while events like summer camps and holiday rides build community. The PTM will use the \$25,000 grant from the award to support its standby trolley power project, ensuring continued service during power outages.

F. Dr. Howard Jack Outstanding Public Educator Award

Sally Jeswilkowski, a kindergarten teacher at Wylandville Elementary, is driven by a deep love for teaching, inspired by those who believed in her. Her dedication creates a nurturing environment where every student feels seen and valued. Whether supporting a struggling child during the pandemic or organizing a penny drive for a student battling cancer, Sally teaches the power of kindness, resilience, and generosity. For her, teaching is a calling, and every child she touches is a testament to her heart and hard work.
