### **Hearing of the Public:**

Doug Murphy, Chairman asked for any public comment. There was none, as no members of the public were in attendance.

Doug Murphy, Chairman called the public meeting of the Erie County Community Services Financing Authority to order at 2:01pm.

### Resolution: Presbyterian Homes Amendment approval\*:

Jay Alberstadt presented Resolution outlining the amendments being made to 2010 & 2014 deals for Presbyterian Homes, as the swap on these deals is expiring and being replaced. Additionally, this requires modifications to the interest rates as the underlying 250-point LIBOR rating is changing to a 200-point SOFR rating over the next couple of years. Furthermore, Jay indicated the Board would need to decide what fee the Authority will charge for the modifications of the loans. Board discussion ensued. It was determined the Board would support a 1% fee (\$15K plus legal fees).

On a motion by Anita Kuchcinski and seconded by Doug Murphy, the resolution and fee were unanimously passed.
