We were thrilled to welcome the **Erie County Gaming Revenue Authority (ECGRA)** to our St. Ann's Campus on October 1, 2025, for their announcement of \$570,000 in community investments through the Anchor Building Grant Program!

Sarah Reed Children's Center was honored to receive a \$55,000 Anchor Building Grant to support Phase 2 of our exterior masonry restoration project, which began July 31, 2026, and was completed August 21, 2026.

Preserving this historic campus means preserving a place where children feel safe, supported, and inspired to learn.

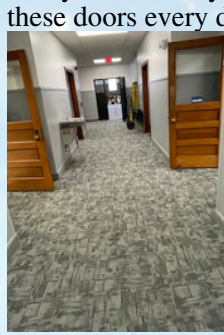
Historic Door Project: Honoring History, Enhancing Safety

As part of our \$103,996 Neighborhood Assistance Program (NAP) project, six original wooden doors on the first floor of St. Ann's Campus have been carefully restored, while 23 new doors have been installed throughout the building. The project was made possible through the **Pennsylvania Department of Community and Economic Development (DCED)** and the generous support of **UPMC Health Plan, Erie Insurance, C.A. Curtze Co., and ERIEBANK**.

Steve Rimpa and his team at **Schutte Woodworking, LLC** meticulously preserved the craftsmanship and character of the historic doors, while **Frontier General Contracting, Inc.** installed the new doors using the same custom stain to create a seamless, cohesive appearance throughout the campus. Together, these improvements honor the rich history of our 100-year-old building while enhancing its safety and security for the children, families, staff, and visitors who walk through these doors every day.

Every enhancement creates a stronger foundation for the life-changing care and educational opportunities our children receive each day.

ECGRA Grant Supports Phase 2 of St. Ann's Campus Repointing & Masonry Restoration



Thanks to a generous **\$55,000 Anchor Building Grant** from the **Erie County Gaming Revenue Authority (ECGRA)**, Sarah Reed is continuing the restoration of the historic St. Ann's School through the expertise of the team at **Northwest Restoration, Inc.** Building on the success of Phase 1, this recently completed phase includes masonry repointing, exterior cleaning, foundation repairs, and other preservation work to protect the building's historic character. They even refreshed our flag pole with a new coat of paint! This effort is part of our ongoing **\$1.4 million St. Ann's Campus Enhancement Project**, launched in 2022 to preserve this treasured school for future generations. Since then, more than 400 children and 1,000 families have benefited from the programs and services provided on the St. Ann's Campus.

We continue to be grateful to ECGRA for its continued investment in preserving this historic Erie landmark and supporting the children and families we serve.

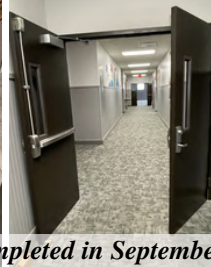
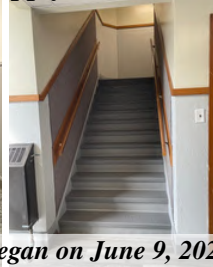
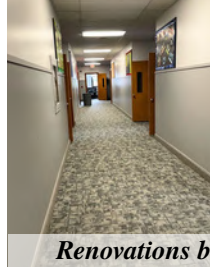
The St. Ann's Campus Got a Refresh During Summer 2025—Inside and Out

“Without knowing who will walk through our door each morning, we await them with a smile and a ‘Good Morning’ that’s not always reciprocated, rather exchanged for a mumble, grumble, or maybe even ignored. **Some of our students don’t get off to a great start each day and face challenges we have never encountered.** So, imagine the feeling on the day when a student makes eye contact, then another day they mumble an angry ‘Hi,’ then a quiet ‘Good Morning’ ... As the appearance and amenities improved, those behaviors subsided greatly. **I believe, along with our staff members' efforts, that an improved building has had a positive impact on our students' progress and growth both emotionally and academically.** Recently, the mother of a student was very impressed by the interior environment of our school, calling it "quaint" and "cozy."*

As a 27-year employee of Sarah Reed, I have seen the transformation of this building and am very appreciative of the efforts that went into this. I now see it as the "crown jewel" of the Pulaski-Lighthouse neighborhood!"



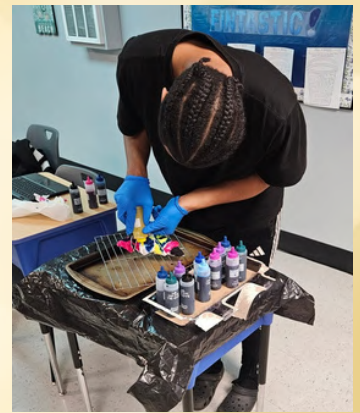
