Consumer Disclosure: For prize, the odds of winning are based upon the number of entries received.

Eligibility: This drawing is sponsored by Erie Federal Credit Union (“Erie FCU”), 3503 Peach Street, Erie, Pennsylvania 16508.

During the period of Monday June 1st through end of business day on Tuesday, June 30th entries can be made for the 90th Anniversary Giveaway Basket “Rooted in Erie Since 1936” prize basket valued at \$300.00

Registration will end at 5 pm on Tuesday, June 30th. The winning name will be chosen at random on Wednesday, July 1st. It is the sole responsibility for winner to pick up and transport prize to their residence. Erie FCU is not responsible for any possible damages that may occur during transportation of prize to winner’s residence.

Drawing is open to all legal Pennsylvania residents of the United States who are 18 years of age or older. Erie FCU employees, officials, and members of their immediate families are not eligible to participate in the drawing.
