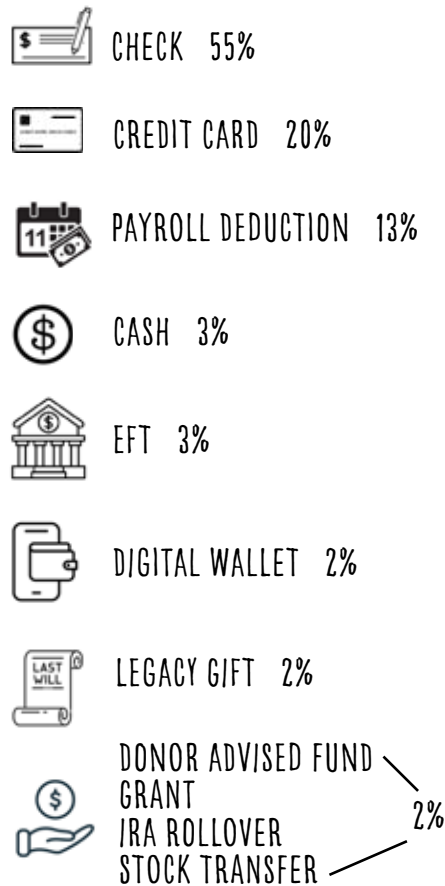

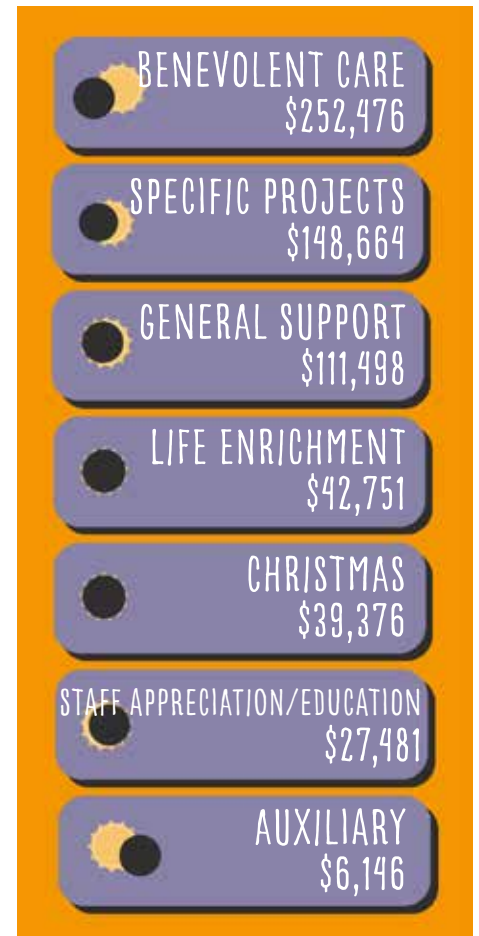

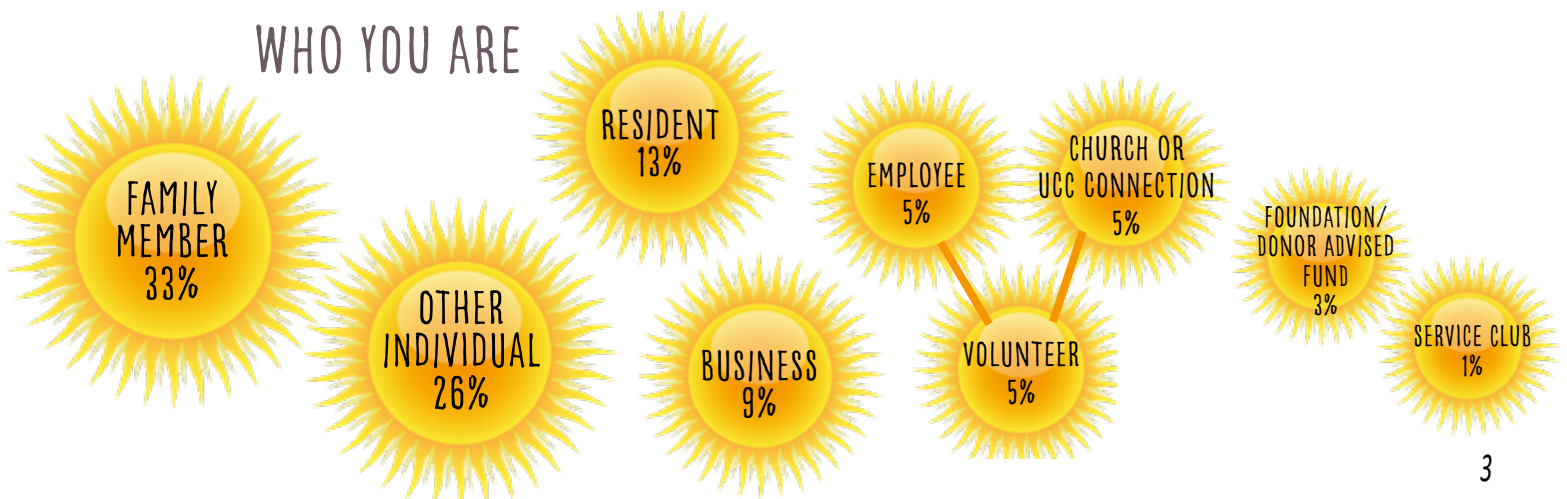

Extraordinary Connection

The story of the Pritts family from Mount Pleasant, Pa., and their connection to St. Paul's is an extraordinary one that has spanned generations.

William "Bill" Eugene Pritts was an active member of the First United Church of Christ in Mount Pleasant, where he served as a deacon and an elder.

Whether it was Reverend Bob Peoples' influence, who was his best friend, or just St. Paul's long-standing connection to the United Church of Christ, Bill was recruited to serve on the board of directors at St. Paul's in 1965 and did so faithfully until 1982. For 17 years, he made the nearly four-hour round-trip drive for board meetings.

Bill was Chair of the Farm Committee and was

Ellen, who live in Fort Myers, Fla., are some of St. Paul's longest-giving donors today.

"My giving was stimulated by his long term board membership," said Bill II. "I do it in honor of him and his service. And because St. Paul's does a fine job."

In addition to their mutual support of St. Paul's, father and son also shared a similar work ethic, though they took different career paths.

Bill established Pritts Feed Mill in Mount Pleasant in 1940 when he purchased the old O.P. Shupe Flour Mill and converted it to feed production.

He was still co-owner of the mill and working alongside his grandson Willy at the age of 96 when he passed away.

"He carried many, many farmers through tough times," said Willy. "One would say he was very kind, helped many people along his journey in life. Although he was a quiet man of few words, he had many strong and kind actions."

Bill II studied management science at Case Institute of Technology (now Case Western Reserve University) in Cleveland, Ohio and had a successful career in business, retiring as the President and CEO of Physicians Data Corporation in 1999.

Both father and son were community-minded, serving several community and philanthropic organizations.

Aside from St. Paul's and his church, Bill served as past president of the Mount Pleasant Chamber of Commerce, a longtime member of Rotary International and a supporter of the Laurel Highlands YMCA.

Bill II is a member of Sigma Nu Fraternity and longtime supporter of United Way. He served as a board member and past president of Shadow Wood Country Club and was a member of the Case Advisory Board from its inception.

St. Paul's is so grateful to the Pritts family for sharing an extraordinary connection with St. Paul's that has lasted for generations.

instrumental in converting the operation at St. Paul's from dairy cattle to beef cattle and crop farming.

He also led St. Paul's through some periods of dramatic transformation with the closing of the orphanage in 1971, the opening of The Colony independent living neighborhood, and the construction of the Health Center.

His sister Ferne Pritts later became a resident of the Health Center, making their family's connection even more personal.

Ferne never married, and Bill took care of her until she needed more care; then he relied on St. Paul's. His grandson William "Willy" Douglas Pritts can recall making the long trip to St. Paul's as a child to visit Aunt Ferne.

When he retired from active board service, Bill was honored as a board member emeritus and remained so until he passed away in 2007 at the age of 96, the oldest living board member at that time.

Bill and his wife Leona had one child William E. Pritts II. Named after his father, Bill II and his wife



St. Paul's achieved an incredible milestone at the end of 2024, surpassing \$1 million raised for the "Bridging the Gap" campaign. This project will improve safety and accessibility by constructing a pedestrian bridge over Williamson Road and paved walking trails that will connect all four neighborhoods at St. Paul's: The Villas, The Heritage, The Ridgewood and The Colony.

Sisters United

As sisters, Mary Ellen and Christine Bayuk are quite different. Mary Ellen is quick to make decisions, Christine takes more time. An ideal day for Christine is in the peace and quiet of the outdoors. Mary Ellen is more talkative and thrives among the hustle and bustle of people and activities.

However they are united when it comes to these foundational traits—a deep love and commitment to their family and to St. Paul's.

Their parents John and Helen Bayuk were born and raised in Greenville in large families of 12 and 8 children respectively. When it came to raising their own family, there was no better place than Greenville, supported by their longtime church St. Michael Roman Catholic Church and a village of extended family.

Mary Ellen is the oldest and Christine the youngest of four siblings. Both left Greenville to pursue their education and careers and have now returned after 40+ years away.

Mary Ellen was the first to move to The Colony at St. Paul's. She was getting ready to retire from the Registrar's office at Penn State Behrend and was in Greenville to take her mother to a doctor's appointment when she decided on a whim to check out The Colony. She put a deposit down the same day, and moved in one day after she retired in 2014.

She isn't the first Bayuk to live at St. Paul's though. "There is a long history in our family and in our lives with St. Paul's," said Mary Ellen, adding with a laugh. "Just about every Bayuk has been through this place."

In recent years, their parents both had short stays here. Their dad's brother Paul Bayuk, his wife Joyce and son Stephen all lived at The Villas until they passed away.

The pandemic brought Christine to St. Paul's earlier than she intended. In March 2020, her job at the Department of Human Services in quality assurance and risk management switched to working remotely. Needing reliable internet, she came to stay with Mary Ellen and got a taste of life in The Colony.

When an apartment became available in 2021, she decided to take it and continue to work remotely until she was ready to retire. After many moves over the years, Christine felt such relief knowing this was the last move she was planning on making. "This is my home now. It's a beautiful campus, and I always feel safe here," she said. "I have freedom and that's very important to me."

Both women became members of St. Paul's Legacy Society in 2024.

Christine added St. Paul's as a

beneficiary of a 457(b) retirement plan simply by filling out a form. Mary Ellen opted to set up a charitable gift annuity to benefit St. Paul's and to provide herself with additional income.

Mary Ellen joked that she made the decision to join the Legacy Society because she heard Christine was and thought, "I'm not letting her do that first!" In truth, it was Mary Ellen's intention all along, given her family's history with St. Paul's and how much she loves living here.

"What I love about living at St. Paul's is the knowledge that I'll be taken care of for the rest of my life, no matter what," said Mary Ellen. She also loves that there is plenty at St. Paul's to keep her busy. She participates in many activities, is an active volunteer and Past President of The Auxiliary, and serves on St. Paul's board of directors, which has given her a unique view. "The people on the board truly care and are truly invested in what's best for the residents and for St. Paul's," she said.

Christine also loves living at St. Paul's and thinks the culture is what really sets it apart. "God is reflected here. There is a sense of that," she said. "The core values really permeate the atmosphere."

In addition to their own experience at St. Paul's, they were also inspired to become Legacy Society members by their cousin Stephen Bayuk, who had special needs and spent his final days at The Villas.

"This was a place that allowed him a measure of freedom for the first time in his life, to be safe, to grow into a person he'd never gotten to be before," said

Christine with tears in her eyes. "The kindness he received, the compassion, the acceptance. This is a gem of a place. It made sense to give here."

When Jean Fagley passed away in July 2024, there was an outpouring of love from family and friends in the form of memorial donations to St. Paul's, including a group who sponsored a tribute bench in honor of Jean and her husband Bob, who still resides at The Heritage.

Bob grew up in Sligo, Pa., and Jean in nearby Curllsville. They both attended Sligo High School and were high school sweethearts, marrying shortly after graduation in 1952. In 2024, they celebrated 72 years of marriage.

Right after high school graduation, Bob enlisted in the Air Force and shipped out to serve 38 months in the Korean War. Based on Oahu at Hickam Air Force Base, Bob was a medic, flying on countless missions to evacuate

injured soldiers. After his tour was done, Bob returned home to Jean and their growing family and began working in the coal fields like many others in the area.

However, determined to chart a better course for his family, Bob took advantage of the GI Bill and enrolled in Clarion University. At that time, librarians were in high demand at schools across the country. Taking summer courses and full credit loads, he completed his degree in library science in just three years.

During that time, Bob was working part-time at a grocery store in Curllsville. He was about to graduate when a delivery driver recommended Bob to the principal at Greenville High School, who was his brother-in-law.

After interviewing Bob and

watching him play on the college baseball

team, he offered Bob two jobs as school librarian and a coach.

Over his 36 year career at Greenville, he coached boy's & girl's basketball, baseball and track. He retired in 1993.

Jean was a homemaker, lovingly raising their five children. Once they were older, she worked in the offices of eye doctors Dr. Gary Roberts and Dr. John Reimold.

Even before moving to Greenville, Jean had a connection to St. Paul's. She grew up attending Grace United Church of Christ in Curllsville. St. Paul's is historically affiliated with the United Church

of Christ and continues to be a mission partner today. The pastor at Grace UCC served on St. Paul's board of directors as did Jean's father Ray Shook. When Bob & Jean moved to Greenville, they became members of Zion's Reformed UCC, which also had a longstanding commitment to St. Paul's.

"She felt she was coming full circle by coming here [to St. Paul's]," said daughter Barb Johnston. "We are very happy with the care here."

Because of that connection, Bob & Jean had already expressed their desire for memorial donations to go to both Zion's and St. Paul's before Jean passed away.

The Fagleys both spent time in The Villas for short stay rehab

in 2019 and 2020. Jean was in The Villas for a second time recovering after a hospital stay in June 2024, when she and Bob made the decision to move to The Heritage.

Bob moved in on July 2. Jean was just about to be discharged to The Heritage when she had a stroke and passed away at 91.

Although their time at The Heritage did not go as expected, Bob and his family are very glad he is here.

"I don't think I could be in a better place," Bob said. "It's not home, but it's the next best thing."

This summer he looks forward to sitting outside in his favorite spot in the fountain courtyard and seeing firsthand as people enjoy the outdoors on the Fagley's tribute bench.

Bertha (Bert) Heckman's life was defined by love, service and devotion. On November 23, 1945, she married her beloved Stanley, and together they embarked on a journey filled with happiness and adventure. Stanley, who passed away on August 18, 1984, was not only her husband but also her closest companion. The love they shared remains a beautiful chapter in the story of Bert's life.

Born on December 19, 1920, in South Attleboro, Mass., Bert grew up with a passion for helping others. She graduated from Attleboro High School and pursued her calling in nursing, receiving her Registered Nurse (R.N.) certification from Pawtucket Memorial Hospital School of Nursing.

Her dedication to the care and well-being of others led her to serve as a Second Lieutenant in the U.S. Army Nurse Corps during World War II. Bert's contributions were invaluable, particularly as she worked in the European Theatre and was involved in the 112th Evacuation during the Rhineland-Central Europe Campaign.

After the war, Bert continued her career in nursing. She worked as an RN at Greenville Hospital and later retired as the Director of Nursing at St. Paul's, where she served from 1966 to 1975.

Her commitment to excellence in healthcare was evident in the countless hours she dedicated to her role, shaping the future of nursing at St. Paul's. She was involved in the interior design of the new Health Center building

as part of the Interior Furnishings Committee and also served on the Medical Care Committee of the Board. Bert was known for going above and beyond, traveling on her own time to other institutions and gathering knowledge that would benefit St. Paul's residents, especially on the topics of drug costs and nursing services.

Bert was the proud mother of two children: son Alan and daughter Rebecca (Heckman) Clark. She also had four grandchildren and seven great-grandchildren, who were blessed to know her and be touched by her gentle spirit.

Bert's dedication to helping others extended beyond her professional life. She was an active member of Zion's Reformed United Church of Christ in Greenville and a long-time volunteer at St. Paul's, giving back to her community in every way she could.

In November 1985, she moved into The Colony, where she continued her life of service and was a friend to many.

"She ended up living in The Colony for longer than she had lived anywhere else in her life," said her daughter Becky Clark. "The staff and administrators enabled her to live a carefree, pleasant life for almost 40 years. She continued to be active, volunteering and taking blood pressures of residents in the skilled nursing units, knitting squares for baby blankets, and was on a committee for writing a book about St. Paul's with some of the kids—now adults—who lived there when it was also a children's home."

In December 2021, Bert made the move to The Ridgewood,

where she continued to share her wisdom, kindness and warmth with those who were fortunate enough to meet her.

"The staff there loved her and treated her with care, compassion and humor. She also made lovely new friends there," said Becky.

On November 7, 2024, at 103 years young, Bert passed away, leaving behind a legacy of compassion, dedication and love that will forever be cherished by her family, friends and all who knew her.

After Bert's passing, her family directed that memorial gifts be made to St. Paul's. "We love St. Paul's," said Becky. "So the decision to allocate memorial donations there was a no-brainer."

In Bert's extraordinary life, she showed an unwavering commitment to family, country and community, and her memory will continue to inspire generations to come.

Cecilia had a special way of nurturing everything in her life, from her plants to her children, creating a home where love thrived.

Sadly Kenneth passed away while their children were still young, but Cecilia, with her fierce determination and loving dedication to her family, supported her

children through those difficult years. She worked various temp jobs before following her heart and becoming an LPN at Passavant Hospital, where she touched many lives over the years with her kind and gentle spirit.

In 1988, Cecilia sold her house in North Hills and moved to Woodbine Drive in Greenville to help her daughter Lois, who was divorced with two school-aged children and a full-time job as a nurse anesthetist at the local hospital.

Cecilia's selflessness knew no bounds, as she offered her love and support to her daughter and grandchildren during a challenging time. After the children grew up and went to college, Lois tragically passed away from lupus in 2005. Cecilia's strength became even more evident as she navigated through the sorrow of losing her daughter.

Cecilia made another big move in 2008—this time, just down the street to St. Paul's. She called her daughter Sue to share that she had visited St. Paul's, put down a deposit for Room 223 at The Heritage and was preparing to sell her home. Sue said her mom was "on top of her game," remaining independent and proactive as she planned this new chapter.

When Cecilia passed away in

July 2024, her family, ever grateful for the love and support she had received at St. Paul's, designated memorial donations to Life Enrichment at The Heritage, where she had spent the last 16 years of her life. Cecilia had a keen sense of independence and joy for life, often participating in Bingo games and taking St. Paul's bus trips.

"Our family is extremely grateful for all the people, staff, and residents who made her life enjoyable and worth living," said Sue. "At one point, I had hired a social worker in Rochester to find the best local senior living center so I could entice mom to move closer to me. My mom would have none of it, she wanted to stay where she was known and happy. We couldn't think of a more fitting place for memorial donations than to those who made her life so content."

BILL WEST

Bill and Delores (Dee) West moved to The Colony at St. Paul's in November 2006, and it became a home where they found not just comfort, but a true sense of community. It was here, surrounded by friends and neighbors, that Bill spent many happy years of his life. He peacefully passed away at The Villas in June 2024 after a brief illness, leaving behind a legacy of love, kindness and cherished memories.

Born on May 24, 1936, Bill grew up in Grove City, Pa., where he graduated from Grove City High School in 1954. His work at the Social Security office in Oil City and New Castle kept him busy for 30 years, but it was his love for the simple joys of life that truly defined him.

Bill had a heart for the things that brought people together, whether it was cooking hearty soups with the ladies of St. Paul's, tending

to his garden or spending time at the bowling alley with friends. He always found happiness in these small acts of connection.

As a dedicated member of Calvary United Methodist Church, a former member of the Greenville Lion's Club, and a volunteer on the board of the Good Shepherd Center, Bill believed in serving others. But it was his family that he loved most of all. Bill married Dee on July 6, 1957, and together they raised three children—Robert, Daniel and Cynthia. They also were blessed with many grandchildren and great-grandchildren who brought endless joy into his life.

Dee was so complimentary about the love and care Bill received while at St. Paul's that she directed memorial donations to St. Paul's.

"St. Paul's has been so good to us," said Dee. "When Bill was in The Villas, the nurses and aides treated him like he was their father. They couldn't have been better to him. When he passed, the nurses came

into the room and cried right along with us. Their care meant the world to us."

Bill adored St. Paul's. He found peace sitting on the front porch of their home in The Colony, chatting with neighbors and watching the neighborhood dogs go by, each of which always brought a smile to his face. The simple moments like these were what mattered most to Bill, and his presence is missed by all who had the pleasure of knowing him.

Paul was always on the move. He truly embraced and celebrated life and all it had to offer right up until the end.

Therefore it was very fitting that he included a bequest in his will, donating his maroon 2018 Honda CR-V to St. Paul's so his friends and neighbors can get wherever they need to go.

The vehicle is being used by Transportation Services to take residents at The Villas, The Heritage, The Ridgewood and The Colony to medical and other off-campus appointments.

"We are so grateful for Paul's donation of his vehicle," said Transportation Coordinator Kelly Bell. "It came at a time that we really needed a new transportation vehicle to take residents to off-campus appointments. It's been a wonderful addition."

Paul and his wife Ann moved to The Colony in 2011. Paul was the manager at the Jamesway department store in Greenville for a number of years. He and Ann had five children, 13 grandchildren and 20 great-grandchildren.

They relished their years at St. Paul's, both staying active and connected. "We have enjoyed our experience

here at The Colony very much," said Ann in a past interview. When asked about what he liked about living at St. Paul's, Paul said, "Everything! I like the people, the atmosphere, the safety and security of being here."

That was true in the good times and in the hard times, like when Ann passed away in 2019 after 52 years of marriage.

A few years later, Paul began spending more time with Gerry McElree, a fellow Colony resident and widow herself.

Neither thought they would fall in love again at this point in life, but that's exactly what happened.

Paul and Gerry became best friends, enjoying each other's company and the fun activities they did together. They also shared a common interest in helping their fellow residents, both serving as volunteers, Auxiliary members and faithful donors.

Thanks to the provisions Paul made in his will, his help continues at St. Paul's today.

RECURRING GIFT

If you'd like to give regularly, become a member of The Orchard Monthly Giving Club. Set it up once and forget about it! It's the easiest way to give. (See pg. 8).

IRA DISTRIBUTION

If you are 70 1/2 or older, you can donate directly from your IRA to St. Paul's. You'll be donating money that has never been taxed, completely tax-free. It's a great way to meet your annual Required Minimum Distribution.

CORPORATE MATCHING GIFTS

Many large employers like Walmart, Home Depot, Verizon, Starbucks and more offer matching funds if their employees donate to charity. You can increase the impact of your gift at no cost to you!

STOCKS, BONDS OR MUTUAL FUNDS

St. Paul's can accept donations of stocks, bonds or mutual funds. You will receive an immediate charitable deduction for the fair market value, and you won't have to pay capital gains tax!

DONOR ADVISED FUND

St. Paul's welcomes gifts from donor advised funds.

LEGACY GIFTS OR PLANNED GIFTS

You can support St. Paul's mission beyond your lifetime by setting up a legacy gift in your estate plan. Here are the most common types:

- **Bequest**
Include a provision in your will or trust to donate a set dollar amount or percentage of your estate to St. Paul's. *See sample language below.*
- **Life Insurance**
Donate a paid up policy you no longer need or name St. Paul's as a beneficiary of your policy.
- **Retirement Account**
Name St. Paul's as a beneficiary of all or a portion of your retirement fund. Since IRAs are the most heavily taxed assets for your heirs, they make an excellent option for charitable giving.
- **Charitable Gift Annuity (CGA)**
Establish a CGA with a gift of \$10,000 or more. You will receive income for life, and the remaining funds will benefit St. Paul's.
- **Charitable Remainder Trust**
Set up a trust with a gift of \$100,000 or more. It provides you (or a beneficiary) with income for life or a set number of years, with the remaining principal going to St. Paul's.

Extraordinary Service

Betty (Defibaugh) Pennington's life has always revolved around serving others, whether it was the people she loved or the places she cared about.

Raised in Quarryville, Pa., she met Rev. L. Collins Defibaugh, a kind man who shared her values of love, faith and service. They married in August 1954 and soon after started their family, raising four children: Debra, Barbara, Stephen and Jeffrey.

Rev. L. Collins Defibaugh, born on July 31, 1927 and educated at Lancaster Theological Seminary (Class of 1954), was a man with extraordinary vision. After graduating, he took on many roles, eventually serving on the Board of Directors at St. Paul's. He was appointed the successor to Rev. Morris H. Cooper in June 1970 and served as Executive Director-Elect under Rev. Cooper until his official retirement on December 31, 1971.

The years spent in Greenville, where St. Paul's played such a central role in their lives, were truly special to Betty. Within their first year at St. Paul's, the board made the difficult decision to discontinue the children's program after 104 years of service, focusing the organization's efforts solely on the aging population.

Following the closure of the orphanage, the organization's name changed to "St. Paul Homes," marking the beginning of a new chapter. The Defibaughs supported this change, understanding the need to adjust to the community's evolving needs.

As Collins led St. Paul's through this transformative period, he and Betty witnessed the expansion of

services that would shape the future of the home.

She stood by her husband's side through the challenges, from the rebuilding of the Keifer Building after a devastating

connection to the people she met here was a source of joy.

The next decade saw more changes at St. Paul's with the board voting to phase out farm operations in October 1986, after 77 years, due to the rising costs.

Three years later, on May 21, 1989, the Defibaugh Alzheimer's Therapy Unit was dedicated at the Health Center, making St. Paul's the first facility in the area to offer specialized care for Alzheimer's patients.

On July 31, 1989, after 19 years of extraordinary service, faithfully supported by Betty, Collins announced his retirement, and G. Bryan Oros, the Assistant Executive Director and Health Center Administrator, was elected to succeed him in this important role.

When Collins passed away in June 2003, Betty moved back to Quarryville to be closer to her family, especially her sister who still lived there. There she reconnected with an old friend, Jim Pennington. Their friendship blossomed into love, and they were married. They shared seven wonderful years together before Jim too passed away.

Looking to start a fresh chapter, Betty moved to Florida to be closer to her daughter Barbara. She's made her home there ever since, and just celebrated her 90th birthday in May—a milestone in a life filled with love, dedication and service.

Despite the changes in her life, Betty's support of St. Paul's has remained. She's been a donor for more than 40 years and still speaks fondly of her time here. "I loved being at St. Paul's," said Betty. "It was a great time in our life. Our children spent most of their school years there. I volunteered there and really enjoyed being with the residents. I enjoyed the town, the Country Club and Thiel College. Those were the best years of our life. I was really active in the community. The small town of Greenville was so homey where everyone felt like family."

Today Betty's ongoing support for St. Paul's serves as a testament to the many years of fulfillment that she and Collins shared in service here. The legacy of their work at St. Paul's continues, honoring the vision they both helped bring to life.
